Gifts that Cost You Nothing Now

BEQUESTS

One of the simplest and most versatile ways to leave a Legacy gift while reducing your estate taxes. In fact, your bequest is a possible way to endow the giving that you have provided during your lifetime. Your bequest to the Donald Danforth Plant Science Center may:

- List a specific amount to be gifted
- Designate a percentage of your estate, for example, 10%, 20%, or 50%
- Leave the residue of your estate after providing for your family and friends

RETIREMENT PLANS, DONOR ADVISED FUNDS

Naming the Danforth Center as the beneficiary of your IRA, 401(k), 403(b), or Donor Advised Fund is a very tax-efficient way to give—and provides a charitable deduction to your estate.

Gifts that Give Back

CHARITABLE GIFT ANNUITIES

In exchange for a gift of cash or securities to the Danforth Center, you receive fixed payments to cover yourself and your loved one. Payments are partially income tax-free and are not affected by ups and downs in the economy.

CHARITABLE REMAINDER TRUSTS

You may be concerned about the high cost of capital gains tax upon the sale of your appreciated property. This gift provides fixed income for life, no capital gains tax on the sale of your appreciated assets, a charitable income tax deduction for the remainder portion of your gift to Danforth Center.



Other Charitable Tax Saving Strategies

- CHARITABLE LEAD TRUSTS: A potential way to pass on some of your assets to your family while reducing or eliminating gift or estate taxes.
- **LIFE ESTATE GIFT:** You gift your home or farm to the Danforth Center, but retain the right to live and use the property for your lifetime while receiving a charitable deduction now.
- DEFERRED GIFT ANNUITIES: Increase your payments from the Danforth Center by delaying receipt until a future date, such as retirement.
